TERMS AND CONDITIONS

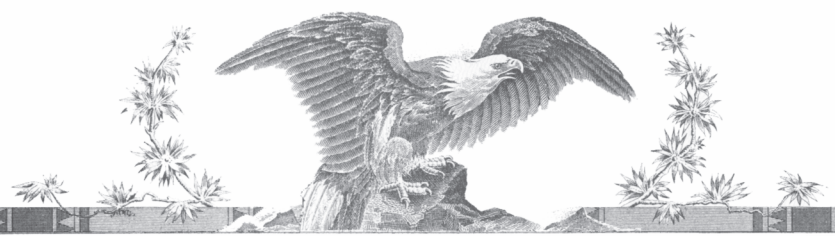

Therefore, be it understood that the prices offered by this Company are based upon a payment in full of all memorials when delivered upon the cemetery lot of the purchaser. It is, therefore, an essential part of this agreement and fully understood that the memorial shall be thus paid for upon delivery and in case the purchaser, by reason of unforeseen circumstances, may be unable to meet the payment promptly when the memorial has been delivered, the amount then due and unpaid shall bear interest at the legal rate until paid.

If the purchaser does not pay amount due hereunder, purchaser agrees to pay the Company reasonable attorney's fees and legal expenses incurred in exercising any of its rights collecting the outstanding balance, therefore all memorials remain property of the Company until paid in full.

Your memorial may be painted with Lithochrome to enhance its legibility. Lithochrome is not permanent, which means it will slowly fade much like exterior house paint.

IT IS UNDERSTOOD AND AGREED THAT THE CONTRACT PRICE DOES NOT INCLUDE THE COST OF ANY LETTERING TO BE ADDED AFTER THE MEMORIAL IS SET IN THE CEMETERY.

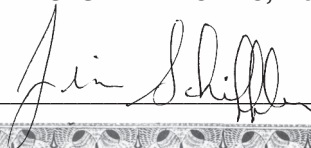
